The descendants of Isaac Turley were discussed and photos and records were displayed. Hortense M. Fuller gave a description of the picture pedigree charts being prepared by Vessa M. Peel, and which should be ready for our next meeting.

Olive has had numerous requests for information regarding the living as well as dead members of the family, taking up much of her time and efforts. This is one instance where this family news letter can help in many ways--helping us to get better acquainted and possibly helping to answer questions dealing with names and where-about's of various members of the family. We solicit your help in suggesting ways and means for making this news letter serve a greater purpose. We will also rely on your help in furnishing news and information of interest to others--such as marriages, deaths, new arrivals, church assignments, both new and fulfilled, missionaries going and coming, temple excursions, etc.

Hazel M. Roy attended a family gathering at Fillmore, Calif. Aug. 17. She brought back many family pictures as well as other information of interest, including 56 family group sheets dictated almost entirely from memory by Anna Harris. This gathering was for the descendants of Mary Ann Turley Cook, who was a sister to Grandfather Isaac Turley. A few of the family have been in attendance at some of the Turley family gatherings at Mesa. Hazel also had the privilege of meeting a descendant of Priscilla Rebecca Turley Lyman, in Long Beach on Aug. 18, 1958. Willis Lyman and wife, Evelyn, were unable to attend the Reunion in Fillmore, so Wilton and Minnie Hunt invited them to lunch the following day, where Grace Hewston also was present.

Vessa M. Peel is working on a complete picture pedigree of Isaac Turley and descendants--also as much of Theodore Turley and family as possible. She asks for the cooperation of all family members in sending in anything in the picture line that will help. This task will entail much time and patience before completed. But think of what it will mean to us and to our future generations!

We hope to have as near a complete history of Isaac Turley and families as we can put together, to place along with that of Theodore Turley and families, combined with picture pedigrees and family group sheets of all family groups now existing, and of those passed on, to be compiled into one complete loose leaf book. What are your ideas concerning this project? We will gladly accept any constructive criticism or ideas to make it the best to be had.

Needed from each family:

- Pedigree chart for Father of family
- Pedigree chart for Mother of family
- Family group sheet of family, dated, complete to date.
- Pictures of family, both as a unit and individual if available
- Brief personal history of both father and mother of family
- Other related photographs of ancestors that may be of interest
- Any historical data in relation to Theodore, Isaac, or their families

We want as complete a record as possible to make and hope to have it microfilmed and placed in church archives as well as church libraries. This is a great task and will take a lot of time, trouble, and money. It can be accomplished if a concerted effort is made by all working together as a unit.

Finances are low in regard to our research program and we appeal to all family heads as well as children to contribute whatever their heart dictates to this worthy cause. Remember that searching out our dead ancestors and compiling their names and family units into the family chain is a PRIESTHOOD RESPONSIBILITY resting on the shoulders of each one of us. You may mail your offerings to either myself or Floyd, L. Barr, or Charles. A receipt will be made out and returned to you at the next family gathering.

After having a good chat with Floyd when he was in Mesa last Aug. 20, we discussed holding the Reunion at Woodruff over the Labor Day weekend and making it a three day affair; thereby getting better acquainted. How do you look upon a three day affair? More about that later.
